CU GOLF TOURNAMENT



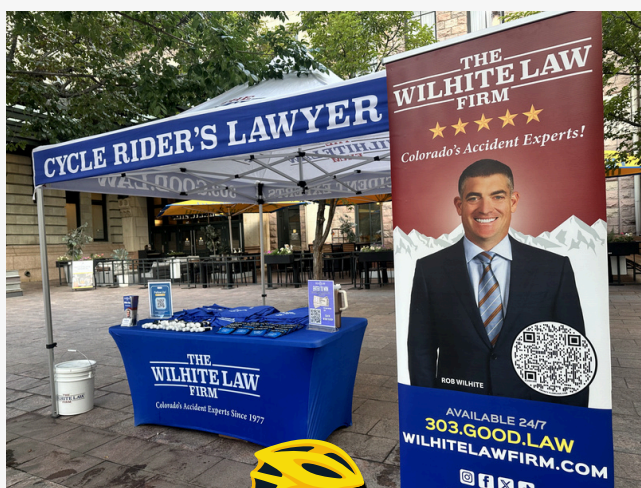

Fun fact: Rob Wilhite is a proud CU alumnus who graduated in 2000!

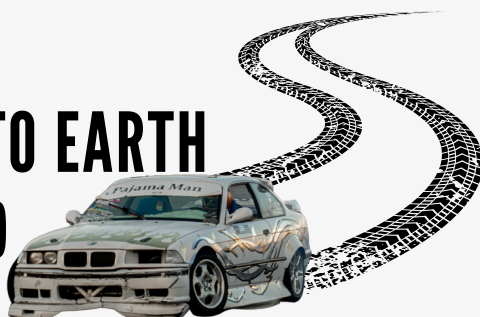
JUNETEENTH PARADE!
